

EON Bank - Free for Life!

- First year free.
- Spend 12 (Classic), 24 (Gold) 36 (Platinum) times in a year for the following year's annual fees waiver.

Basic Requirements

- Photocopy of I.C. (both sides) for principal & supplementary applicant.
- 21 ~ 60 for principal applicant & 18 for supplementary applicant.
- Min annual income: Classic RM18,000, Gold RM 36,000 Platinum RM80,000.

Document Requirements

- ✓ Application must be filled clearly with **BLACK INK** and in **BLOCK** letter for SCANNING purpose.
- ✓ All documents must be in **A4 size** and do not highlight as it cannot be scanned.
- ✓ Application which does not meet the Basic & Document requirement will be upfront rejected by the bank.
- ✓ Unclear document will not be accepted by the bank. Always provide more documents to improve the approval rate.
- ✓ For prompt case, do not provide unnecessary document like low pay slip & EPF statement show low pay.
- ✓ Agent Code must be clearly written in BLACK INK for SCANNING.

For existing Credit Cards / Charge card holders (Prompt – **most preferred** category)

- Above 12 months membership for local issued card
 - Photocopy of current credit card (both sides).

For Classic upgrade to Gold

- Above 12 months membership for local issued card
- Existing Classic Cards with limit of RM5000 or above
 - Photocopy of current credit card (both sides).

For Gold upgrade to Platinum

- Above 24 months membership for local issued card
- Existing Gold Cards with limit of RM15,000 or above
 - Photocopy of current credit card (both sides).

For MNC / PLC / Government employee (MNC & PLC are preferred category)

- Minimum basic salary of RM1500 + fixed allowance.
 - Latest 1 months' salary slips.
 - If basic salary below RM1500, EA Form / Form J with RM18,000 and above must be attached.

For small and medium size (unknown) company's employee

- Minimum basic salary of RM2000
 - Latest 1 months' salary slips and
 - Latest EPF statement or 3 months Bank statement (salary bank-in account).
 - If basic salary below RM2000, min 3 months' salary slips & Bank statement must be attached.

Self-employed / Sole proprietor

- Minimum 2 year in business or minimum 1 year in business for Eon Bank's customer.
 - Latest 3 months' bank statements or personal bank statement.

For Executive Program (Longer processing time, not recommended)

- Executive position for MNC & PLC & Government
 - Call card or copy of employee ID tag

For Lady Program (Not recommended)

- Female employee of small & medium size (unknown) co. which have been established for more than 3 years
- More than 2 years working experience (present/past employment)
- Holding an Executive position
 - Call card or copy of employee ID tag

Commission Earner (Not recommended)

- Included insurance, real estate, unit trust, motorcar sales agent.
 - Minimum 1 year in business. (Full Time Basis)
 - Latest 3 months commission statements.
 - Latest 3 months bank statement (commission bank-in account).

Non-Target Market

- Uniform: Low ranking police, army, navy, air force, enforcement unit & etc. Air, sea crew member.
- Position: Foreigner, non skilled worker or field worker, driver, production operator, security guard, contract worker, renovation worker, office assistant...
- Industry: Pubs. Karaoke, SPA, hawker, small contractor, small food outlet, Moneylender, small leasing and credit companies...
- Income: Less than RM2000 and working in small / less established company.
